All nominees for a position on the ISGH Board of Directors (Shura) are required to sign a statement that he/she, i.e. the person accepting nomination for a position on the ISGH Board of Directors, is qualified as per ISGH Bylaws Article VII, Section 4 {text within the Quotes is a verbatim reproduction from the referenced section}

"Qualification of Nominees and Announcement of Nomination:

A. Qualification of Nominees for a person on the Board of Directors:

(i) Besides begin an eligible voting member for at least one year (2 years for nominees for the position of President or Vice President), all nominees for a position in the Board of Directors must meet the following four conditions:

-Have been involved in ISGH as a Board of Director, Associate Director, or Area Representative or in any of the ISGH or affiliated educational entities.

-Over the last one year, have attended at least one regularly scheduled Quranic or Islamic Adult Education session per month at any of the ISGH centers or Masajid.

- Is not serving as President, Vice President, General Secretary, Treasurer, Ameer, or Imam/Employee of any Islamic organization not affiliated with ISGH, at the time of nomination.

- Has not been an employee of ISGH at any time during the one year period immediately preceding the date of nomination.

-Have not been removed from an elected office of ISGH (as per Bylaws Article VII Section 8) or expelled from ISGH membership for ethical reasons (as per Bylaws Article VII Section 9).

- (a). One who does not him self seeks an elected position.*
- (b). One who does not puts his decisions or other people's decisions over and above the decisions of Allah in the Quran and Sunnah*
- (c). One who is obedient to Shariah*
- (d). One who does not commit major sins."*
