This list of nominees for At Large, Zonal Director, & Associate Director positions is based on the <u>best</u> information available to EC at the time of release and should be considered a <u>PRELIMINARY</u> list only. The process of assessing the qualifications of these nominees as per the ISGH Constitution & Bylaws is a tedious process and it continues.

There are several qualifications checks that need to be made by EC and there is no guarantee that every name appearing on this list has passed all qualification checks at this time. Several of these qualification checks require for EC to have or obtain information that is not readily available, or EC is awaiting response to its request(s). This is particularly true for checking up on Term Limits and qualifications pertaining to previous experience, including service on any of the ISGH Committees, as well as Background Checks.

As this process progresses, it may be necessary to make alterations to this list. <u>EC reserves all rights to add or</u> remove names from this list and to make any other corrections, additions (or deletions) and any other alterations as EC deems necessary at any time before balloting, or, if needed, even after the elections but before <u>EC is dissolved</u>.

A nominee whose name appears on this list may withdraw by submitting a written request to EC. The deadline for withdrawals is <u>12 Noon on November 13, 2022</u>. Please submit your withdrawal to EC via email at <u>EC2022ISGH@gmail.com</u>. If for whatever reason a nominee does not have access to email then he/she MUST contact EC at 832-978-9822 (via text message) to make arrangements to hand over any withdrawal in writing.

There are strict rules about "Prohibited Relationships" that restrict concurrently holding ISGH offices by members who are related to one another. Please do understand such restrictions and withdraw accordingly if you and relative(s) of yours are nominated, or relative(s) of a nominee already holds ISGH office(s). It is impossible for EC to know of all relationships of conflict as per the ISGH Bylaws. Therefore, understanding and recognizing such prohibited relationships and what to do is sole responsibility of Nominees. Understand that in case nominees do not reveal and/or withdraw due to "prohibited relationships" then ALL thusly connected Nominees will be DISQUALIFIED from ALL positions.

As mentioned above, any nominee listed here in should be cognizant of the fact that this is a PRELIMINARY list and there is no guarantee that his/her name will otherwise appear on the final list when all qualifications checks have been completed.

Similarly, anyone who believes that his/her name <u>SHOULD</u> have been <u>INCLUDED</u> in this list but do not see their name should immediately contact the EC2022. Please be sure of your qualifications prior to contacting the EC2022 to discuss any issues or concerns. Further, if your nomination was incomplete or invalid you would have received an email notification from EC2022. If you did not follow up and responded then your name is NOT included here in.

All Nominators & Nominees should be fully aware of various requirements for respected positions. "Ignorance of Law" is/will NOT be an acceptable excuse for subsequently disqualified Nominations.
